Furthermore, we accept that for the purpose of continuous verification:

- NSAI may at any stage verify the conformity control methods applied in each production facility. NSAI will carry out or arrange to be carried out on its behalf, such verifications at least once every three years. NSAI will give notice of its intention to carry out verifications to approval holders prior to the verification exercise. The approval holder shall grant NSAI access to the manufacturing, inspection, testing, storage and distribution sites and shall provide all necessary information with regard to the quality management system documentation and records. NSAI may request a technical service to carry out the surveillance activities on its behalf;
- the frequency of these inspection events will be based on a risk assessment carried out by NSAI and/or the minimum time intervals specified by each (EC/EU) Directive/Regulation or UNECE Regulation;
- the fees associated with a Continued Verification are levied on the approval holder, who makes a commitment to pay for these in accordance with the customary payment terms and conditions set. Failure to do so will result in the suspension of type-approval and may lead to a withdrawal of the type-approval;
- At the time of the surveillance audit, records of tests or checks and records of production shall be made available to the inspector.
  when the surveillance audit takes place, records of tests or checks and records of production, in particular records of documented tests or checks, shall be made available to the inspector;
- the minimum number of samples taken for the purpose of physical testing is agreed between NSAI and the technical service before the surveillance audit takes place;
- the inspector shall verify that the product conformity arrangements implemented by the approval holder are those which were submitted to NSAI at the time of initial assessment;
- where the inspector or whoever deems it necessary to verify the validity of the tests that were carried out is of the opinion that the level of control is unsatisfactory, samples shall be sent to the technical service to perform physical tests in accordance with the requirements on conformity of production, set out in the regulatory acts;
- where unsatisfactory results are found during an inspection or a monitoring review, NSAI will take all necessary measures to ensure that the approval holder restores the conformity of production as rapidly as possible. Failure to do so will result in a withdrawal of the type-approval.
